

## NOTICE OF CONSTRUCTION

### Nootka Road – Road Reconstruction Notice

We would like to update and inform the residents on Nootka Road that we are planning to start the Road Reconstruction next week. This means that we will be closing the road in the **orange** area below toward the end of next week. We expect the closure to happen on **Thursday, June 10<sup>th</sup> or within a few days after this date.** We will be closing the road for approximately one week in the **orange** area to excavate the road from the new monowalk that has been installed up to and including the opposite curb. We will then complete subgrade improvements and start graveling. Once we have the road graveled within the **orange** area, parking will be available on the new gravel and we will need to close the road in the **green** area below. Each stage is expected to take approximately one week to get to the gravel stage. After the entire road has new gravel, new curb and gutter will be pour for the entire length of the road. After all concrete has been poured, we will finalize the roadway gravel for paving.



During construction we ask that residents park in the rear lane if they have this option to allow for construction to proceed and to provide additional parking for those with front driveways that do not have access. For the houses that have front driveways, we ask that you utilize your driveway for parking to keep the streets free of vehicles during construction if at the stage where your driveway is available. Once any concrete is poured, we ask that it is not driven on for at least 7 days to allow for it to cure properly and obtain the strength required to support the weight of a vehicle.

Please put your garbage out as per normal. Our crew will be relocating the bins on garbage day to an area where garbage trucks have access and returning them at the end of the day. We will be writing your house number on any bins that are not tagged to ensure they get relocated to the correct house on garbage collection day.

**Residents will be expected to cooperate with the daytime parking restrictions that will be in effect for any areas being worked on, in order to allow for the street improvement construction in front of their property to safely progress. We thank-you for patience and cooperation due to the construction inconveniences so far! We ask that residents continue to keep their distance from the equipment; maintain 2m separation from any workers; and watch their children for all of the obvious safety reasons.** We apologize for any inconveniences due to construction and we thank you for your cooperation during any inconvenient times.

Please advise the Excavation/Gravel contacts below if your property has sprinklers within one meter of the existing concrete that may require special attention. Landscape restoration will not take place until after the paving is complete in the fall.
