ELIGIBILITY

All Employees qualify for the LRC Membership discount as soon as they start working for the City of Leduc.

HOW DO YOU SIGN UP FOR A MEMBERSHIP?

Bring your City of Leduc ID card along with a form of payment (cash, debit, credit card, or a blank cheque for automatic withdrawal) to Guest Services at the LRC. Your membership will be set-up right away!

STAFF PAYMENT PLAN

The Staff Payment Plan allows City of Leduc Employees to pay for their membership in monthly increments. A credit card or blank cheque for automatic withdrawal is required.

These rates are in effect as of January 1, 2020. Annual or 6-month memberships are non-transferable. Memberships can only be cancelled if moving or for medical reasons with a doctor's note provided. This is a non-taxable benefit and the discount cannot be applied to individual admissions, flex passes, registered programs, personal training and child minding. 6-Month Membership is issued only once annually.
