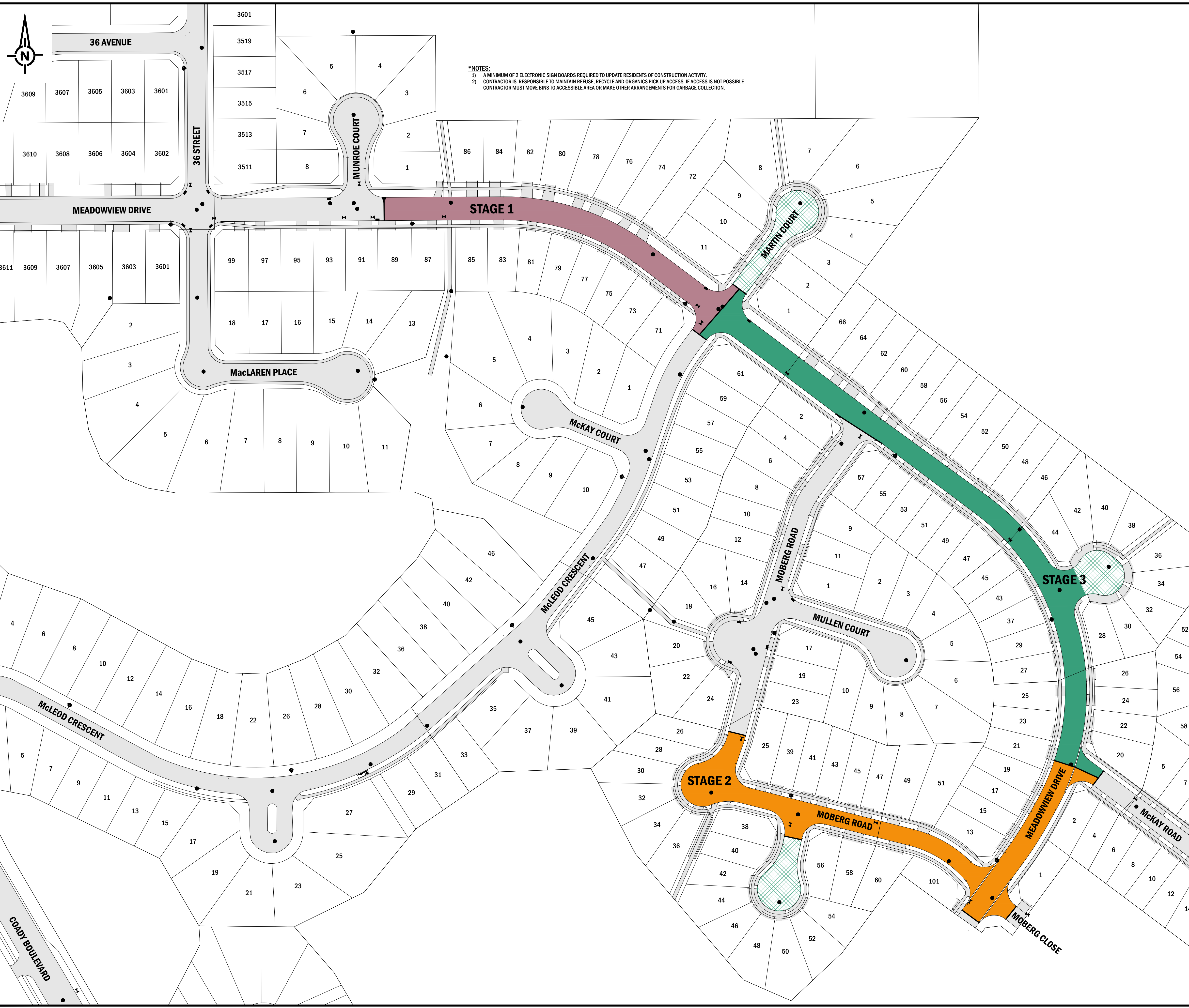

- ALL EXISTING UTILITY LOCATIONS MAY NOT BE SHOWN. ANY EXISTING UTILITIES THAT ARE SHOWN ARE APPROXIMATE. THE CONTRACTOR IS RESPONSIBLE FOR THE VERIFICATION OF LOCATION AND PROTECTION OF ALL EXISTING UTILITIES, WHETHER SHOWN ON THE DRAWINGS OR NOT. CONTACT ALBERTA ONE-CALL AT 1-800-242-3447 AND DIG SHAW AT 1-866-344-7429 PRIOR TO ANY CONSTRUCTION TO DETERMINE THE EXACT LOCATION OF UNDERGROUND UTILITIES.
- THE CONTRACTOR SHALL ENSURE THAT ALL UNDERGROUND COMMUNICATIONS CABLES AND OTHER SPECIFIC LINES HAVE BEEN LOCATED AND PROTECTED PRIOR TO EXCAVATION.
- 48 HOURS NOTICE OF ROAD CLOSURES MUST BE PROVIDED TO ALL AFFECTED RESIDENCES AND BUSINESSES PRIOR TO CLOSING ROADWAYS FOR CONSTRUCTION.
- ADJUST ALL EXISTING MANHOLES, VALVES, AND CATCHBASINS (WHERE APPLICABLE) AS REQUIRED TO SUIT PROPOSED ROAD WORKS.
- ALL DISTURBED AREAS ARE TO BE REPAIRED, REPLACED AND/OR LANDSCAPED TO NEW CONDITION. CONCRETE OR ASPHALT REPAIRS SHALL BE CUT AND SQUARED TO THE SATISFACTION OF THE RESIDENT ENGINEER. LANDSCAPED REPAIRS ARE TO BE TOPSOILED AND SEED TO A MINIMUM DEPTH OF 75mm AND MAINTAIN POSITIVE DRAINAGE.
- EXISTING CONCRETE CURB, GUTTER OR WALK WITCH IS DEPRESSED OR DEEMED REPLACEABLE BY THE ENGINEER SHALL BE REMOVED AND REPLACED AS REVIEWED.
- CONTRACTOR TO ENSURE A SMOOTH TRANSITION BETWEEN PAVED SURFACES.
