CONDITIONS FOR OPEN BURNING

Burning shall be carried out in compliance with the following conditions;

- 1. At least one (1) responsible adult with available means to extinguish the fire in an emergency, shall be in attendance to monitor and control the fire.
- 2. The fire shall be located in an area free of dry grass, brush or combustible soil and adequate clearances to any combustible material shall be maintained.
- 3. Wind conditions shall be less than 25 km/hr and blowing away from any highway or residential area.
- 4. Consideration must be given when smoke generation may obscure visibility on adjacent roads.
- 5. Material classified as "Burnable Debris" are those permitted to be burned in accordance with statutes and bylaws written to protect and enhance the environment, and shall include but are not limited to materials described as:

I. straw and stubble,ii. grass and weeds,iii. leaves and tree prunings,

iv. brush and fallen trees on newly cleared land or associated logging operations, v. used power, telegraph and telephone poles that do not contain wood preservatives,

vi. wooden material from the construction or demolition of buildings which does not contain wood

preservatives,

vii. solid waste from sawmills or planing mills with an annual production of less than 6500 cubic

meters of lumber,

viii. solid waste from post and pole operations that does not contain wood preservatives,

ix. solid waste from tree harvesting operations.

6. Material described as "Prohibited Debris" are those that when burned, will result in the release to the atmosphere of dense smoke, or toxic air contaminants in accordance with statutes and bylaws written to protect and enhance the environment, and shall include but are not limited to materials described as:

I. animal cadavres,
ii. animal manure,
iii. pathological waste,
iv. non-wooden material,

v. combustible material in automobiles, vi. combustible material in automobile bodies,

vii. tires,

viii. rubber or plastic, or anything containing or coated with rubber or plastic or similar substances,

except rubber or plastic attached to shredded scrap steel,

ix. solid waste from sawmills or planing mills with an annual product in excess of 6500 cubic meters

of lumber, used oil,

xi. wood or wood products containing substances for the purposes of preserving wood, and

xii. household refuse.

- 7. The fire shall be completely extinguished before leaving the area.
- 8. If this Fire Permit has been obtained to burn material to thaw ground, the following special conditions shall also apply:
 - The permit holder shall arrange to have the fire attended during periods of high wind, or when other situations arise when surveillance may be required.
 - ii. Residents in the immediate vicinity shall be made aware of the particular work being done in their area and the purpose of the fire, prior to ignition.
 - iii. A barricade or sign (clearly stating the company's or a person's name and phone number) shall be provided so that if the Fire Services Department should respond to the location, the Officer in charge will know who is responsible for the fire.
- Contact Fire Services at 780-980-8475 prior to lighting fire to advise that fire will be ignited.

This Permit shall be presented to a member of the Fire Services Department when requested to do so.

ADDITIONAL CONDITIONS:

- 1. Please be well aware of the <u>wind speed</u> and <u>wind direction</u>. Please ensure that proper fire control is available.
- 2. Please ensure that an adult is at the site to monitor the fire at all times.
- 3. Please keep the fire low to prevent sparks from becoming airborne.
- 4. Please call the following telephone number prior to burning advising the start time and the finish time of the burning:

DURING OFFICE HOURS - Monday to Friday 8:30 a.m. until 12:00 Noon and then from 1:00 p.m. until 4:30 p.m., please call 780-980-8475

- 5. EACH TIME you would like to conduct a burn, you must fill out and submit an Open Air Burn Inspection Checklist by emailing to fireservices@leduc.ca. This checklist can be found on the City of Leduc's website at:
