2.1	Jack & Jill Playschool	S. Weinstein made a presentation regarding their GTO proposal and addressed the questions from the Board.

Recommendations from the Board: Approve one-year funding at a reduced amount of \$18,000.00 – same amount as last year's approved grant. The Board believes that the program could still run successfully without the financial support from the City, by exploring other avenues for funding. The Board supports Jack & Jill Playschool with their plan to acquire a charitable organization status with Canada Revenue Agency, and believes that they will highly benefit from it.

Some highlights of her presentation are: Men & women online groups were held year-round and a total of 53 attended the sessions. Some families reached out to other programs and resources in the community such as trauma group, and wellness group, which FVPT provided in partnership with

In the last year, 75 counselling sessions were approved for children and their families. Changes with staffing – there is a new Chair and a few new committee members. The group is re-establishing goals and preparing new welcome packages. The Family Violence Prevention Team has around 20 members from community organizations around the City, who work in areas related to families and children. C. Tabone answered the Board's questions. 3.4	Round Table	 Round table discussion and update: Feedback from the community indicated that people are generally happy with restrictions being lifted and businesses are slowly opening up, and vaccines are easily accessible and available to eligible Canadians. Some concerns with COVID vaccine not available for younger children and the lack of general guidance from Alberta Health Services (AHS) about wearing masks in certain locations. Residents in the Deer Valley community are not supportive of an off-leash dog park in their area. Council suspended the municipal mask bylaw indefinitely on March 8, 2021 and the City of Leduc follows the provincial 	

4.0	OLD BUSINESS	 government's guidelines. Wearing a mask is a personal choice and the City ask people to be kind, considerate and supportive of each other. Telus is installing fibre optic technology for internet in the businesses and residential areas. Expect to see trenching and Telus vault/boxes installed in utility right of way. Vehicle charging stations will be installed downtown in the ATB parking lot. It will cost around \$16,000.00 powered by a solar array. The Edmonton International Airport (EIA) is setting up a fund, supported by all municipalities in the region, to bring back international air services at EIA. The 15-million-dollar fund will provide incentives to airlines to bring back and grow our international air services. This fund will be managed by Edmonton Global, and the City of Leduc is supporting this in the amount of \$330,000.00 in the next 2 years, to boost the economic development in Leduc. 	
4.1	Homelessness Task Force	 The Homelessness Task Force received a presentation from M. Haggerty, E.D. at Leduc Regional Housing Foundation (LRHF). She talked about the programs at LRHF and explained affordable housing versus subsidized housing and funding sources. Presenter at next meeting will be Jessica Hutton from Open Door homeless shelter in Camrose.
