This event connects young individuals (ages 18-30 years old) looking to build leadership skills and learn about the non-profit sector with non-profit organizations looking to enhance diversity through youth engagement.

- April Chair attended Pitch-in events with LWCS and Communities in Bloom.
- May 7 Arbour Day. Very well organized (thank you Keri and Shannon!) and a very successful event. Lots of families came out and the advertising was effective. LEAB passed out more native seeds and had a QR code at the table for people who were interested in the Pollinator challenge. Thanks to the board members for coming down to help out.
- Strategic Plan Environmental Sustainability is reassuring that those are things that are heart of the focus of the Strategic Plan

B. Council's Report

- Arbour Day fun facts there was 161 participants total 2.5 hours all the trees were planted. We ran out of trees before the event was over. Really nice to see the Wetlands restoration. Really beautiful area
- AVPA update; Council has been working hard to find some amendments. They measure the noise along with the contours which can hold restrictions on development, height of buildings etc. North of Telford is zoned to be commercial or industrial. Council is lobbying hard they want the area to be like Calgary and Airdrie, so the hope is City of Leduc will get the same treatment. Should there be changes LEAB should try and be apart of those conversations in regards to Berms & Buffers

- E Scooters was launched last week, great for tourism and mobility. Anyone over the age of 16 can use it. Great initiative for the City of Leduc. Kudos to GHG Group
- West Campus the long-term plans is for a 2nd rec facility near the new high school. July 1st there will be consultation with groups. 18 months later they will regroup and will go over budget
- CEIP launches May 30, 2022, check out the myceip website to get all the information prepared so when the applications open you are ready to go
- Check out the Strategic Plan if you haven't yet. There are a lot of Environmental goals within the plan.

C. Administration's Report

- Update on Arbour Day was a great success! Excellent turn out (161 participants beyond City staff and volunteers) and lots of engagement with residents on environmental initiatives. And we got 725 trees in the ground. A big thankyou to everyone who volunteered their time to represent LEAB.
- Reminder that CEIP launches May 30th! We've received lots of interest and spots are limited so be sure to apply as quickly if you can if you're interested in making energy efficient upgrades to your home (anticipating room for 30 participants each year). Our home energy kits are coming together and should be ready for May 30th
- The E-scooter pilot program was officially launched Friday, May 6th! We confirmed that there is a liability waiver to be completed through the app (and credit card information is collected) and the scooters are designed to operate within City limits only.
- We have another staffing change to highlight one of our Administrators is moving roles within the city. With that, Keri has received a promotion and her role will be changing in our department as well. We will have a new staff member gradually transitioning into her role which means a new face at these meetings. Keri will still be present into the fall to help support this transition!
